How the integration works:

Network (payer)

Payments are paid in Everflow and payment information is stored in Tipalti. When payers click "Pay" on an invoice in Everflow, the payment syncs automatically to Tipalti. To view payment history (e.g., all payments made each payment cycle), payers need to access Tipalti's "Payment history" screen in the AP Hub.

Affiliates (payees)

If affiliates do not yet have payee IDs in Tipalti and they enter Everflow's affiliate portal (Tipalti's iFrame), they are created automatically as payees in Tipalti. Affiliates can update their data in the portal and the updates will sync to Tipalti; however, their data is not stored in Everflow. All payee history is stored in Tipalti.


